SURVEY NOTES:

- A SURVEY WAS CONDUCTED TO RECOVER THE BOUNDARY CORNERS OF THE PREVIOUS SURVEY BY DENNIS W. LOOPER KY. L.L.S. #3437 OF PURCHASE AREA SURVEYING INC. ON MARCH 13, 2002. THIS SURVEY WAS USED TO DETERMINE THE BOUNDARY CALLS IN DEED BOOK 434 PAGE 550. ALL CORNERS CALLED FOR IN SAID RECORD WERE IN PLACE AND IN GOOD ORDER TO PERPETUATE THEIR LOCATION. THEREFORE SAID CORNERS ARE HEREBY HONORED FOR THEIR LOCATION UNLESS OTHERWISE NOTED.
- UPON COMPLETION OF THE BOUNDARY SURVEY, THE OWNERS WISHED TO CONSOLIDATE THEIR TRACTS AND REMOVE THE INTERIOR BOUNDARY LINES. THIS WORK IN CONJUNCTION WITH ESTABLISHING THE LIMITS OF THE BARNETT CEMETERY ROAD IS SHOWN HEREON AND IS THE PRIMARY PURPOSE FOR THIS PLAT.
- TRACT "A" AND THE ROADWAY KNOWN AS "BARNETT CEMETERY ROAD, AS SHOWN HEREON, HAVE NO DEDICATED DEED REFERENCE. THEIR LATEST KNOWN REFERENCE WAS MADE AS PART OF THE DEED FROM H.W. WRYE TO BILLY J. WILLIAMS AND MARRY ANNA WILLIAMS, HUSBAND AND WIFE, IN DEED BOOK 92 PAGE 388 IN THE CALLOWAY COUNTY CLERKS OFFICE.
- TRACT "B" AS SHOWN HEREON HAS NO KNOWN DEDICATED DEED REFERENCE. THE ONLY KNOWN RECORDED EVIDENCE SHOWING THIS AS BEING PART OF THE BARNETT CEMETERY ARE THOSE OF ITS ADJOINERS WHO HAVE RECOGNIZED AND ACKNOWLEDGED THIS LAND AS BEING PART OF THE BARNETT CEMETERY.
- SUBSURFACE EXPLORATION WAS NOT CONDUCTED TO DETERMINE THE LIMITS OF THE GRAVEYARD. SURFACE FEATURES WERE OBSERVED TO HELP DETERMINE THESE LIMITS. FURTHER EXPLORATION MAY BE NECESSARY TO DETERMINE THE EXISTENCE OF ANY ENCROACHMENTS.
- THE SOLID NODES ALONG THE CENTERLINE OF BARNETT CEMETERY ROAD ARE FOR GRAPHICAL REPRESENTATION ONLY. NO ACTUAL MONUMENTS WERE SET IN THE FIELD AT THESE LOCATIONS.
